We refer to the above SEBI order dated 22<sup>nd</sup> March, 2016 and directions issued to the client Companies of M/s. Sharepro Services (India) Private Limited (hereinafter referred to as Sharepro) to carry out audit of records lying with Sharepro in relation to dividends paid and transfer of securities to determine whether dividend have been paid to actual / beneficial holder and securities have been transferred as per the provisions of the applicable laws.

M/s. JAYSYNTH DYESTUFF (INDIA) LIMITED (The Company) CIN: L24114MH1985PLC035564 having its Registered Office situated at 301 Sumer Kendra, P B Marg Worli, Mumbai-400018 has appointed Sharepro having registered office at 13AB Samhita Warehousing Complex, 2nd Floor, Andheri-Kurla Road, behind Sakinaka Tel. Exch. Andheri East Mumbai - 400072 as the Registrar and Transfer Agents since 27th November, 2000. The Company has appointed our Firm as Auditors for the purpose of conducting audit under the aforesaid SEBI order.

As directed, we have carried out the audit of records and systems of Sharepro for the period commencing from 1st April, 2006 to 31st March, 2016. The scope of the audit was limited to the verification of processes and records maintained and made available by Sharepro with respect to the transfer of shares, transmissions of shares, dematerialization of shares dividend declared and to the extent of physical verification of transfer request. Dematerialisation applications and Share Certificates.

# KAUSHAL DALAL & ASSOCIATES COMPANY SECRETARIES

During the course of the audit, Sharepro had provided the following records and registers maintained by them in Physical and Electronic Forms:

- 1) Details of Shares and Share Certificates.
- 2) Details of Share Transfer including share transfer deeds, Transmission requests and Dematerialisation requests.
- 3) Benpos from 1st April, 2006 to 31st March, 2016.
- 4) Dividend data for F.Y.2013 2014 and F.Y.2014 2015.

Sharepro is responsible to ensure compliance of the applicable provisions pertaining to transfer of shares, transmission of shares and dividend distribution under the relevant provisions of Companies Act, 1956/2013 and erstwhile Listing Agreement and SEBI (Listing Obligations and Requirements) Regulations, 2015. The responsibility of our audit is restricted to carry out inspection of the records and systems of Sharepro.

Based on the records and data provided by Sharepro the audit was carried out by verifying all the Transfer Deeds, application of transmission of Shares, Share Certificates, applications for dematerialisation of shares, applications for deletion of name, cross verification of signature of aforementioned documents with database maintained by Sharepro. As informed by the Company, dividend had been declared for F.Y. 2013-2014 and F.Y. 2014-2015 thus verification of the list of Shareholders as on record date for respective financial years was done to determine whether dividend was paid to actual/beneficial holder. After the detailed examination of the documents provided to us we report the following observations in the Audit:

### **OBSERVATIONS:**

- 1) There were certain errors noticed in Demat Request Forms in relation to discrepancy in name of the shareholder and Share Certificate number.
- 2) During the course of the audit, certain documents were not provided details of which are mentioned in <u>ANNEXURE I</u>. In regards to such documents Sharepro has issued a letter dated 16th June, 2016 to the Company. Copy of the letter is annexed as <u>ANNEXURE II</u>.

On the basis of our verification of the records/database provided by Sharepro, we hereby report that except the afore – mentioned discrepancies Sharepro has transferred and dematerialised shares as per the applicable provisions of law and dividend has been paid to the actual/beneficial holders of the securities.
