Subject: Reply on Audit Report of Mr. Kaushal Dalal of M/s. Kaushal Dalal & Associates, Practising Company Secretary in respect of Order issued against Sharepro submitted to Securities and Exchange Board of India ("SEBI") on June 21, 2016

Dear Sir/Madam,

This is with reference to the SEBI order No. WTM/RKA/MIRSD2/41/2016 dated March 22, 2016 in the matter of Sharepro Services (I) Pvt. Ltd. ("Sharepro").

As per the SEBI directions, Mr. Kaushal Dalal of M/s Kaushal Dalal & Associates as appointed by the Company to conduct the SEBI Audit had conducted the Audit of Records and systems of Sharepro Services (India) Private Limited and the said Audit Report was submitted to SEBI on June 21, 2016 by the Company. The Audit report mentioned that certain documents were not provided for Audit during the course of Audit and List of such missing documents was marked as Annexure-I to the said report. With respect to the said missing documents, Sharepro Services (India) Private Limited had provided a letter dated June 18, 2016 stating that the documents will be provided after the handover process of all the other Companies is over and the said Letter was attached to the report as Annexure-II.

In compliance with the directions received from SEBI mentioned in the said order, the Company has changed its Registrars and Transfer Agent from M/s Sharepro Services (I) Pvt. Ltd. to M/s Link Intime India Private Limited who are duly registered with the Securities and Exchanges Board of India (SEBI) under SEBI (Registrar to an issue and Share Transfer Agents) Regulations 1993 as Registrar and Share Transfer Agents for the Equity Shares of the Company w.e.f. June 01, 2016.

The Company had co-ordinated with both the RTAs i.e M/s. Sharepro Services (India) Private Limited (Company's previous RTA) as well as M/s. Link Intime India Private Limited (Company's existing RTA) in respect of the missing documents mentioned by the Auditor in his Report. After personal visits by the Secretarial Department of the Company to both the RTAs, they have been able to access and trace the following missing documents mentioned in Annexure – I of the Auditor's Report:
